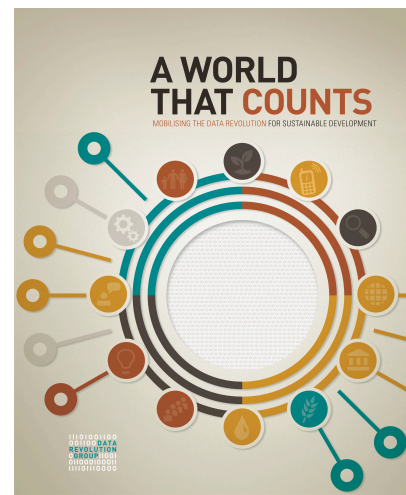
### Aims

The aim of the side event is to explore developments in Open Data, the Data Revolution and the implications for sustainable development particular for developing countries.

**Data are the lifeblood of decision-making and the raw material for accountability. Without high-quality data providing the right information on the right things at the right time; designing, monitoring and evaluating effective policies becomes almost impossible.**

**Never again should it be possible to say “we didn’t know”. No one should be invisible. This is the world we want – a world that counts.**

The session will be opened by a keynote from Claire Melamed, who will speak about the recent UN IEAG Report, *A World That Counts: mobilizing the data revolution for sustainable development*.



This will provide a broader context for the presentation of the proposed revised to the **GEO Data Sharing Principles post-2015** and the **GEO Data Management Principles**. These Principles will be discussed in conjunction with ‘Nairobi Principles and Draft Guideline for Implementation of Principles of Preservation of and Open Access to Research Data in Developing Countries’ developed on behalf of CODATA.

It will be particularly important to include in the discussion a broad range of international perspectives, particularly members of AfriGEOSS and representatives of other developing countries. The side event will engage participants in constructive conversation on how the principles can contribute to increased data sharing and use in the developing world, and in particular seeking African perspectives on the use of GEOSS data.
